Change Order 1 and Contract Close-Out

**Information**

The 2016 Street Rehabilitation Contract II was the large resurfacing and concrete project for 2016, with some work carrying over into spring and early summer 2017. All work was completed to compliance, and the project punch list completed. The result is a net underrun on original contract value, resulting in a change order value of a net decrease of \$15,685.10. E&B Paving has submitted all necessary paperwork including waiver of liens, consent of surety to final payment, and three year warranty bond.
