Attached is a contract with Miller Surveying, Inc. to complete topographic survey and legal descriptions for three parcels at Greenfield Avenue over Lehr Ditch. Site investigation last year identified that the existing culvert structure needs to be replaced. The new structure will be sized to accommodate trail connections and future roundabout at Greenfield Avenue and Marilyn Road. Contract is a lump sum contract of \$12,250.
