1- 6' X 7' PAIR OF WIDE STILE CLEAR ANODIZED ALUMINUM STOREFRONT DOORS AND FRAME WITH 5" MIDRAILS, AND 10" BOTTOM RAILS. WE INCLUDE 1" INSULATING CLEAR GLASS IN THE UPPER LITES AND 1" CLEAR ANODIZED ALUMINUM PANELS IN THE LOWER LITES. WE INCLUDE 1- ADA POWER ASSIST OPERATOR, BOLLARD POST, PRESSPLATES, 1- MANUAL CLOSER, 2- 12" PULL HANDLES, DEADBOLT LOCK KEYED BOTH SIDES, AND FLUSHBOLTS.



Exterior Door Project at the Public Safety Building

Board of Works,

This project proposal is for the rehabilitation and replacement of the exterior doors and entrance vestibule interior doors at the Public Safety Building. Currently the doors on the Public Safety building are not in satisfactory condition or in proper operating condition. There are many issues including corrosion of the door frames, hardware/structural issues, and appearance.

I am planning on using the Public Safety Bond money to fund the project. I understand that this is acceptable because it relates to the permanent components and HVAC/insulation of the building.

The Suburban Glass and Central Indiana Hardware quotes are less than the final proposal costs because they figured the 9th Street entrance vestibule doors two different ways, then added both figures to the final cost in the proposal. One cost was for new doors and hardware and the other cost for new hardware on our existing doors in the vestibule. We have decided to go with new doors and hardware. I have listed the final proposal prices below.

Suburban Glass: \$43,825.00 (Omit \$5200.00 (9th St. interior door hardware only)).

Door Equipment Co.: \$48,280.00. (No omissions).

Central Indiana Hardware: \$56,735.27 (Omit \$1236.32 (2 Mullions at \$618.16 each)).

I recommend that Suburban Glass be awarded with the contract for the project at the Public Safety Building. I have attached the contract for approval.
