## RESOLUTION NO. RC-10-18

## A RESOLUTION OF THE COMMON COUNCIL OF THE CITY OF NOBLESVILLE CONCERNING REPEAL OF PREVIOUS RESOLUTIONS FOR ECONOMIC REVITALIZATION AREAS

WHEREAS, on the 12<sup>th</sup> day of May, 2015, the Common Council of the City of Noblesville passed Resolution No. RC-13-15, a Confirmatory Resolution Designating an Economic Revitalization Area for Noblesville Senior Real Estate, LLC, which designated an Economic Revitalization Area for the increased value of Real Estate included for Hamilton County Parcel 11-11-18-00-09-001.000; and,

WHEREAS, on the 24<sup>th</sup> day of November, 2015, the Common Council of the City of Noblesville passed Resolution No. RC-36-15, a Confirmatory Resolution Designating an Economic Revitalization Area for Dura Products, Inc., which designated an Economic Revitalization Area for the increased value of Real and Personal Property included for Hamilton County Parcel 10-11-05-00-06-001.000; and,

WHEREAS, on the 20<sup>th</sup> day of December, 2016, the Common Council of the City of Noblesville passed Resolution No. RC-48-16, a Confirmatory Resolution Designating an Economic Revitalization Area for Abrasive Waterjet of Indiana, LLC, which designated an Economic Revitalization Area for the increased value of Real and Personal Property included for Hamilton County Parcel 10-11-00-00-006.000; and,

WHEREAS, on the 15<sup>th</sup> day of August, 2017, the Common Council of the City of Noblesville passed Resolution No. RC-29-17, a Confirmatory Resolution Designating an Economic Revitalization Area for Get Fresh Produce at 9210 E. 146<sup>th</sup> Street, which designated an Economic Revitalization Area for the increased value of Real Estate included for Hamilton County Parcel 11-11-18-00-08-002.000; and,

WHEREAS, none of the projects described in the above resolutions have been initiated.

IT IS THEREBY RESOLVED by the Common Council of the City of Noblesville as follows:

- The Resolutions described above are repealed and the creation of the above described Economic Revitalization Areas are vacated.
- The Clerk is requested to provide copies of this Resolution to the Hamilton County Assessor.
