#### **ORDINANCE NO. 19-05-18**

AN ORDINANCE TO AMEND THE UNIFIED DEVELOPMENT ORDINANCE AND OFFICIAL ZONING MAP, ALL PART OF THE COMPREHENSIVE PLAN OF THE CITY OF NOBLESVILLE, HAMILTON COUNTY, INDIANA

This Ordinance amends the Unified Development Ordinance for the City of Noblesville, Hamilton County, Indiana, enacted by the City of Noblesville under authority of Chapter 174 of the Acts of the Indiana General Assembly 1947, as amended.

WHEREAS, the Plan Commission of the City of Noblesville (the "Plan Commission") conducted a public hearing on docket number 0072-2018 at its May 21, 2018 meeting as required by law concerning a change of zoning of certain property; and,

WHEREAS, the Plan Commission has sent a Favorable recommendation for adoption of said amendment with a vote of seven (7) in favor and zero (0) opposed to the Common Council;

**NOW, THEREFORE, BE IT ORDAINED** by the Common Council of the City of Noblesville, Hamilton County, Indiana, meeting in regular session, that the Unified Development Ordinance and Zoning Map, are hereby amended as follows:

- The Zone Map (see Exhibit D illustrating current zoning for reference) is hereby amended to change the zoning of the following as designated in said Unified Development Ordinance for the City of Noblesville, Hamilton County, Indiana.
  - A. A change in zoning of the parcel legally described in Exhibit A from the Smithfield Business Park Planned Development (Ordinance 47-5-06) to the Corporate Campus Planned Development ("CCPD") with the Subdistrict of Industrial/Office and a Character Overlay of 146<sup>th</sup> Street Corridor";
  - B. A change in zoning of the parcel legally described in Exhibit B from the CCPD with the Subdistrict of Office/Flex and a Character Overlay of 146<sup>th</sup> Street Corridor to the CCPD with the Subdistrict of Industrial/Office and a Character Overlay of 146<sup>th</sup> Street Corridor"; and
  - C. A change in zoning of the parcel legally described in Exhibit C from the CCPD with the Subdistrict of Industrial/Office and a Character Overlay of Internal to the CCPD with the Subdistrict of Industrial/Office and a Character Overlay of 146<sup>th</sup> Street Corridor".
- <u>Section 2</u>. This Ordinance shall be in full force and effect from and upon its adoption and publication in accordance with the law.




