THE APPLICANT IS RESPONSIBLE FOR ENSURING THAT THE FOLLOWING REGULATIONS ARE MET AT ALL TIMES. FAILURE TO MEET ANY OF THE FOLLOWING WILL RESULT IN THE DENIAL OR REVOCATION OF THIS PERMIT AND POSSIBLE ENFORCEMENT ACTION BEING TAKEN AS OUTLINED BY THE CITY OF NOBLESVILLE CODE OF ORDINANCES.

- 1. Encroachment permits are required for any obstruction, use, or activity within a public right-of-way or city easement.
- 2. The undersigned shall notify the Designated Department(s) a minimum of 14 days prior to the time the activity is to take place in order to assure the existence of available resources.
- 3. In cases where the activities authorized by the permit will interfere with traffic flow on streets, the application will be assessed by the Noblesville Police Department, Noblesville Fire Department, and the Noblesville Street Department to determine number of necessary City personnel and/or equipment and a fee will be assigned based on number of persons/equipment and the total number of hours for the event.
- 4. The applicant shall hold harmless and indemnify the City of Noblesville from, for and against any claim of any person in tort, contract, or otherwise arising out of the act or omissions of the applicant, their agents, representatives, participants, etc.
- 5. Any applications for encroachments under this section must include a site plan that details specifically the number and location of encroachments. Site plans should also include identification of uses on each section of their location or route.
- 6. All applications must be approved by the Board of Public Works and Safety and may be subject to conditions set out by the Board, and are not eligible for an administrative approval.
- 7. All applicants shall be required to submit to the Designated Department proof of Insurance for general liability within the (10) business days that states that the City of Noblesville, Indiana is listed as an additional co-insured. The minimum insurance requirement shall be \$1,000,000 per occurrence, \$300,000 per person, and \$50,000 for legal unless the Board of Public Works and Safety decides to reduce or Increase the amounts.

2017 Hamilton County Law Enforcement Torch Run for Special Olympics

On Friday, June 2, 2017, officers from local law enforcement agencies within Hamilton County will take part in a county-wide Torch Run to raise awareness and funds for Special Olympics Indiana. Special Olympics athletes from Hamilton County and around the state will be participating in this year's Special Olympics Summer Games in Terre Haute, Indiana on June 9-11, 2017. Officers representing the Carmel Police Department, Fishers Police Department, Hamilton County Sheriff's Department, Hamilton County Prosecutor's Office, Indiana State Police, Noblesville Police Department and Westfield Police Department will take part in this fundraising effort. Each agency will start at a designated location throughout the county based upon their respective jurisdiction. All of the participating agencies will then simultaneously converge on downtown Noblesville at 12:30pm where they will be joined by local athletes of Special Olympics for a lap around the Noblesville downtown square. Representatives from Special Olympics will address those in attendance on the east side of the old courthouse located on 9th Street between Conner and Logan Street.

The 2017 Hamilton County Law Enforcement Torch Run will commence at approximately 10:30am as officers leave their designated starting locations and begin their trek towards downtown Noblesville. Agency starting locations and routes are listed below:

Start at the Carmel Police Department South on Rangeline Road to Carmel Drive East on Carmel Drive to Keystone Parkway South on Keystone Parkway to 116th Street West on 116th Street to Rangleline Road North on Rangeline Road to Carmel Police Department Drive from Carmel Police Department to downtown Noblesville

Fishers Police Department (Agency contact: Sgt. Scott Wilcox)

Start at Harrison Parkway Elementary North on Harrison Parkway to 146th Street East on 146th Street to Herriman Blvd. North on Herriman Blvd. to Wellington Parkway West of Wellington Parkway to Allisonville Road North on Allisonville Road to downtown Noblesville

Hamilton County Sheriff's Department, Indiana State Police (Agency contact: Deputy Bryant Orem)

Start at 146th Street and Olio Road North on Olio Road to SR 38 West on SR 38(32) to Cumberland Road North on Cumberland Road to Field Drive West on Field Drive to S.R. 19 South on S.R. 19 to downtown Noblesville

Noblesville Police Department, Hamilton County Prosecutor's Office (Agency contact: Lt. Bruce Barnes)

Start at Hamilton Heights High School in Arcadia

South on S.R. 19 to downtown Noblesville

Westfield Police Department (Agency contact: Patrolman Mike Wheeler)

Start at Westfield High School in Westfield South on Union Street to S.R. 32

East on S.R. 32 to downtown Noblesville

All participating agencies will plan to arrive in downtown Noblesville at approximately 12:30pm. Each agency will cover a distance of approximately 4-8 miles and will have support vehicles and personnel assisting along each respective route. A total of approximately 60 officers will be participating. This event will take place regardless of weather conditions.
