ORDINANCE NO. 18-05-18

AN ORDINANCE AMENDING THE UNIFIED DEVELOPMENT ORDINANCE NO. 62-12-95, "THE PROMENADE" PLANNED DEVELOPMENT ORDINANCE NO. 6-1-06, AND ALL AMENDMENTS THERETO, A PART OF THE COMPREHENSIVE MASTER PLAN FOR THE CITY OF NOBLESVILLE, HAMILTON COUNTY, INDIANA

An Ordinance to amend the Unified Development Ordinance and Ordinance No. 6-1-06, and all amendments thereto for the City of Noblesville, Hamilton County, Indiana, enacted by the City of Noblesville under the authority of Chapter 174 of the Acts of the Indiana General Assembly 1947, as amended, and

WHEREAS, the Plan Commission of the City of Noblesville has conducted a public hearing on Application No. LEGP 0060-2018 as required by law concerning waivers being granted regarding signage for the St. Vincent Neighborhood Hospital, a part of the "Promenade Planned Development", all a part of the Unified Development Ordinance and after due consideration has sent a favorable recommendation for adoption to the Council with a vote of <u>8</u> ayes and <u>0</u> nays at their May 21, 2108 meeting, and

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Noblesville, Hamilton County, Indiana, meeting in regular session, that the Unified Development Ordinance, and Ordinance No. 6-1-06 "The Promenade" Planned Development Ordinance, and all amendments thereto are hereby amended as follows: **SECTION 1.** That the subject real estate located at 6139 Promenade Shops Boulevard and legally described as Lot 7 in "The Promenade Shops" subdivision also known as Hamilton County Parcel No. 10-06-34-00-00-022.003 which is located within the zoning jurisdiction of the City of Noblesville, Hamilton County, Indiana and is currently zoned PB/PD Planned Business Planned Development.

SECTION 2. That this ordinance and attached "Exhibit 1" indicates the proposed signage for the St. Vincent Neighborhood Hospital and specifically the location of the signage on each elevation including the size, colors, and type. As per the "Exhibit 1" the following waivers are granted: (1) one additional sign on the south elevation, (2) two additional signs on the canopy; (3) one sign indicating entrance on east elevation, and (4) increase in the size of the signs indicating "emergency" and "entrance". The sizes and locations of the signage shall be as per the illustrations on the attached "Exhibit 1".

SECTION 3. Unless a development standard, specification, guideline, and/or requirement contained in the Unified Development Ordinance or "The Promenade" Planned Development Ordinance No. 18-05-18 is varied, altered, or modified by this ordinance and/or exhibits, then such development standards, specifications, guidelines, and/or requirements as specified in the Unified Development Ordinance and/or the Crossing Planned Development Ordinance No. 23-06-14 shall apply.

SECTION 4. This Ordinance shall be in full force and effect from and upon its adoption and publication in accordance with the law. All prior ordinances or parts thereof in conflict therewith are repealed and deemed to conform to the provisions of these amendments.




