

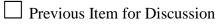

Re: 2017 Street Rehabilitation – Contract II (EN-281-02) Change Order 1

Information

The 2017 Street Rehabilitation Contract II was the large resurfacing and concrete project for 2017, with some work carrying over into spring and early summer 2018. This change order resulted from additional work that was added to the contract this spring, including emergency repairs to Little Chicago Road, 171st Street, and 146th Street. Contingency funds were available within the budget to complete additional necessary work on Summer Road and Cumberland Road. A breakdown of these costs are attached. As the contract value was also under budget, the total of these additional projects is also partially "included" in the original contract amount. All work was completed to compliance, and the project punch list completed. The result is a net increase on original contract value, resulting in a change order value of an increase of \$289,576.95.
