## An Ordinance Approving an Amended Preliminary Development Plan for Multi-Family Area 1 in the Noble West Planned Development Overlay District





## **EXHIBIT B**

A part of the Southeast Quarter Section 16, Township 18 North, Range 4 East in Noblesville Township, Hamilton County, Indiana, being more particularly described as follows:

Commencing at the southeast corner of said quarter section; thence North 00 degrees 09 minutes 25 seconds East (assumed bearing) along the east line thereof a distance of 1773.01 feet; thence South 89 degrees 50 minutes 35 seconds West a distance of 70.00 feet to the **Point of Beginning**; thence North 89 degrees 41 minutes 58 seconds West a distance of 1272.29 feet to the west line of the east half of said quarter section; thence North 00 degrees 08 minutes 06 seconds East along said west line a distance of 284.99 feet to the centerline of the abandoned railroad right-of-way; thence North 65 degrees 59 minutes 37 seconds East along said centerline a distance of 1394.58 feet to a point being 70.00 feet (measured perpendicular) from said east line of said quarter section; thence South 00 degrees 09 minutes 25 seconds West parallel with said east line a distance of 859.04 feet to the **Point of Beginning**, containing 16.71 acres, more or less.
