AN ORDINANCE TO AMEND THE UNIFIED DEVELOPMENT ORDINANCE, A PART OF THE COMPREHENSIVE PLAN OF THE CITY OF NOBLESVILLE, HAMILTON COUNTY, INDIANA

An Ordinance to amend the Unified Development Ordinance of the City of Noblesville, (the "City") Hamilton County, Indiana enacted by the City under the authority of Chapter 174 of the Acts of the Indiana General Assembly 1947, as amended.

Whereas, City's Plan Commission ("the Commission") has conducted a hearing as on Application No. 07N-14-0501 as required by law in regard to the application for approval of a Change of Land Use a part of the Corporate Campus Planned Development and filed by the City of Noblesville; and

Whereas the Commission has sent to the Common Council its favorable recommendation by a vote of 10 ayes and zero nays at their May 21, 2007.

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Noblesville, Hamilton County, Indiana, meeting in regular session, that the Ordinance is hereby amended as follows:

SECTION 1. That the land use category for said designated property known as Parcel No. 10-11-17-00-00-014.000 and as per the following legal description:

The eastern 1,500-FT off of the thirty (30) acres off of the entire South end of the Northwest Quarter of Section 17, Township 18 North, Range East of the Second Principal, in Hamilton County, Indiana.

be changed from Single-Family Residential with a subdistrict overlay of Mixed Residential to Industrial/Office with a subdistrict overlay of Internal as per Exhibit "A" Said property is located within the Corporate Campus Planned Development and is located in the 15000 block of Cumberland Road, East Side.

SECTION 2. Any and all land use categories and subdistricts of the Unified Development Ordinance and the Corporate Campus Land Use and Subdistricts Map not specifically revised and amended by this Amendment shall remain unchanged and in full force and effect, and as previously amended by other duly enacted amendments.

This Ordinance shall be in full force and effect from and upon its adoption in accordance with the law. Adopted this LILL day of Jene, 2007 by the Common Council of the City of Noblesville, Hamilton County, Indiana.


