ORDINANCE NO. 47-10-09

AN ORDINANCE AMENDING THE UNIFIED DEVELOPMENT ORDINANCE NO. 62-12-95, ZONE MAP, AND THE CORPORATE CAMPUS LAND USE AND SUBDISTRICTS MAP AND ALL AMENDMENTS THERETO, A PART OF THE COMPREHENSIVE DEVELOPMENT PLAN FOR THE CITY OF NOBLESVILLE, HAMILTON COUNTY, INDIANA

An Ordinance to amend the Unified Development Ordinance for the City of Noblesville, Hamilton County, Indiana, enacted by the City of Noblesville under the authority of Chapter 174 of the Acts of the Indiana General Assembly 1947, as amended, and

WHEREAS, the Plan Commission of the City of Noblesville at their October 19, 2009 meeting conducted a public hearing on Application No. 09N-15-1097 as required by law concerning the change of zoning and the adoption of a preliminary development plan and has sent a favorable recommendation for adoption of said amendments with a vote of 9 ayes and zero nays and 1 abstention to the Common Council.

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Noblesville, Hamilton County, Indiana, meeting in regular session, that the Unified Development Ordinance and Zoning Map, are hereby amended as follows:

SECTION 1. That the zone map is hereby amended to change the zoning on parcels legally described in "Exhibit A" from "R2" Low to Moderate Density Single-Family

Residential to "R2/GUO" Low to Moderate Density Single-Family Residential/Government Use Overlay district and known as the Eastside Park planned development.

SECTION 2. That the Government Use Overlay shall include the following variations regarding the Preliminary Development Plan (Exhibit B):

- 1. The allowance of overflow parking in the Grassland area of the adopted master plan. The proposed overflow parking area shall remain grassland and not require the pavement and curb standards as per the Unified Development Ordinance.
- 2. The softball complex shall be permitted to have lighted fields without the benefit of another public hearing.

SECTION 3. This ordinance and its Exhibits (collectively, the "Preliminary Development Plan") permit variations from the development standards, specifications, guidelines and/or requirements (collectively, the "Standards") contained in the City's Unified Development Ordinance. The adopted preliminary development plan supersedes the Standards in the City's Unified Development Ordinance, for this specific use and Real Estate, to the extent the preliminary development plan varies, alters, or modifies the Standards in the City's Unified Development Ordinance. The Standards in the approved Unified Development Ordinance, however, shall apply to the extent that the preliminary development plan does not vary, alter, or modify them.

SECTION 4. This Ordinance shall be in full force and effect from and upon its adoption and publication in accordance with the law.

SECTION 5. Upon motion duly made and seconded; this Ordinance was fully passed by the members of the Common Council this 10th day of November , 2009.
