ORDINANCE NO. 5-1-08

AN ORDINANCE AMENDING THE UNIFIED DEVELOPMENT ORDINANCE NO. 62-12-95, ZONE MAP, AND THE CORPORATE CAMPUS LAND USE AND SUBDISTRICTS MAP AND ALL AMENDMENTS THERETO, A PART OF THE COMPREHENSIVE DEVELOPMENT PLAN FOR THE CITY OF NOBLESVILLE, HAMILTON COUNTY, INDIANA

An Ordinance to amend the Unified Development Ordinance for the City of Noblesville, Hamilton County, Indiana, enacted by the City of Noblesville under the authority of Chapter 174 of the Acts of the Indiana General Assembly 1947, as amended, and

WHEREAS, the Plan Commission of the City of Noblesville at their January 22, 2008 meeting conducted a public hearing on Application No's. 07W-14-1979, 07W-15-1981, and 07W-15-1980 as required by law concerning the zoning of a parcel located in Wayne Township, the creation of the land use category and character subdistrict, and the overlay district of Government Use Overlay and has sent a favorable recommendation for adoption of said amendments with a vote of 11 ayes and zero nays to the Common Council.

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Noblesville, Hamilton County, Indiana, meeting in regular session, that the Unified Development Ordinance, Zoning Map, and Corporate Campus Land Use and Subdistricts Map are hereby amended as follows:

SECTION 1. That the zone map is hereby amended to zone the parcel Corporate Campus Planned District (CCPD). The Corporate Campus Land Use and Subdistricts Map shall be amended to Industrial/Office with a Subdistrict of Secondary Corridor for the following described property:

Part of the Northeast Quarter and part of the Southeast Quarter of Section 14, Township 18 North, Range 5 East in Wayne Township, Hamilton County, Indiana and more particularly described as follows: Beginning at the Southeast corner of the North Half of the Southeast Quarter; thence North on and along the East line of said Section 14, approximately 2,330 feet to the Northeast corner of the South 33.0 acres of the East Half of the Northeast Quarter of said Section 14; thence West on and along the north boundary of said 33.0 acre parcel 871 feet; thence South 500 feet; thence East 71 feet, thence South approximately 1,830 feet to the North line of the South Half of the Southeast Quarter of said Section 14; thence East on and along said north line 800 feet to the Point of Beginning, containing 43.6 acres, more or less.

SECTION 2. That the northern ten (10) acres of this parcel described above shall amend the Zone Map so to include the overlay district of Government Use Overlay (GUO) for the following described property:

Part of the Northeast Quarter of Section 14, Township 18 North, Range 5 East in Wayne Township, Hamilton County, Indiana and more particularly described as follows: Commencing at the Southeast corner of the North Half of the Southeast Quarter; thence North on and along the East line of said Section 14 approximately 2,330 feet to the Northeast corner of the South 33.0 acres of the East Half of the Northeast Quarter of said Section 14 and the Point of Beginning of this description; thence West on and along the north boundary of said 33.0 acre parcel 871 feet; thence South 500 feet; thence East 871 feet, thence North 500 to the Point of Beginning containing 10.0 acres, more or less.

That the Government Use Overlay shall include the following variations regarding the Preliminary Development Plan (Exhibit A):

- 1. Percentage and type of building materials
- 2. Percentage and type of landscaping materials for the building base, parking lot and perimeter site landscaping
- 3. Allowing two curb cuts


- 4. Allowing a gravel drive for the fire trucks located west of the proposed parking and continuing to the retention/detention pond.
- 5. Varying requirements of the Noblesville Standards
- 6. Varying requirements of the Noblesville Technical Standards for Storm Water
- 7. Elimination of parking lot curbing for portions of the parking area(s).

SECTION 3. This Ordinance shall be in full force and effect from and upon its adoption and publication in accordance with the law.
