## ORDINANCE NO. 17-06-13

AN ORDINANCE AMENDING THE UNIFIED DEVELOPMENT ORDINANCE NO. 62-12-95 AND ALL AMENDMENTS THERETO AND THE OFFICIAL ZONING MAP FOR THE CITY OF NOBLESVILLE, HAMILTON COUNTY, INDIANA

Portion of Hamilton County Parcel No. 13-11-23-00-00-011.000

An Ordinance to amend the Unified Development Ordinance and Official Zoning Map for the City of Noblesville, Hamilton County, Indiana, enacted by the City of Noblesville under the authority of Chapter 174 of the Acts of the Indiana General Assembly 1947, as amended, and

WHEREAS, the Plan Commission of the City of Noblesville has conducted a public hearing on Application No. 13N-14-6041 as required by law concerning the text amendments and has sent a favorable recommendation to the Council with a vote of \_\_9\_ ayes and \_\_0\_ nays at their June 17, 2013 meeting, and

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Noblesville, Hamilton County, Indiana, meeting in regular session, that the Unified Development Ordinance and Official Zoning Map are hereby amended as follows:

SECTION 1. That the current land use category designation of "Office" with a Subdistrict Overlay of "Interchange", a part of the Corporate Campus Planned Development District shall be reclassified to the land use category of "Commercial" with a Subdistrict Overlay of "Interchange", a part of the Corporate Campus Planned Development District as per "Exhibit A" and as per the

Amended and Restated Development Agreement dated June 14, 2005 between the City of Noblesville, Noblesville Redevelopment Commission, and Noblesville Redevelopment Authority (The Governments), and Interchange Diversified, LLC (The Developer). The area is bounded roughly by Campus Parkway to the North, Hamilton Town Center to the East, and 136<sup>th</sup> Street to the South and containing approximately 80 acres.

SECTION 2. This Ordinance shall be in full force and effect from and upon its adoption and publication in accordance with the law. All prior ordinances or parts thereof in conflict therewith are repealed and deemed to conform to the provisions of these amendments.
