AN ORDINANCE AMENDING THE UNIFIED DEVELOPMENT ORDINANCE NO. 62-12-95, AND ALL AMENDMENTS THERETO, A PART OF THE COMPREHENSIVE MASTER PLAN FOR THE CITY OF NOBLESVILLE, HAMILTON COUNTY, INDIANA

An Ordinance to amend the Unified Development Ordinance and all amendments thereto for the City of Noblesville, Hamilton County, Indiana, enacted by the City of Noblesville under the authority of Chapter 174 of the Acts of the Indiana General Assembly 1947, as amended, and

WHEREAS, the Plan Commission of the City of Noblesville has conducted a public hearing on Application No. 001043-2015 as required by law concerning a waiver to the Federal Hill Planned Development District of the Unified Development Ordinance and after due consideration has sent a favorable recommendation to the Council with a vote of 10 ayes and 0 nays at their June 15, 2015 meeting, and

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Noblesville, Hamilton County, Indiana, meeting in regular session, that the Unified Development Ordinance, and all amendments thereto are hereby amended as follows:

SECTION 1 That said waiver reducing the established parking lot setback of twenty feet is hereby reduced for those parking spaces indicated on the attached site plan as per "Exhibit A." indicating a reduction of between one foot to nine feet. This property is part of the redevelopment for Federal Hill Commons and is bounded by Logan Street, State Road No. 19, Westfield Road

(State Road No. 32) and Nixon Street, all within the zoning jurisdiction of the City of Noblesville, Hamilton County, Indiana.

SECTION 2. Unless a development standard, specification, guideline, and/or requirement contained in the Unified Development Ordinance is varied, altered, or modified by this ordinance and/or exhibits, then such development standard, specification, guideline, and/or requirement as specified in the Unified Development Ordinance shall apply.

SECTION 3. This Ordinance shall be in full force and effect from and upon its adoption and publication in accordance with the law. All prior ordinances or parts thereof in conflict therewith are repealed and deemed to conform to the provisions of these amendments.

SECTION 4. Upon motion duly made and seconded; this Ordinance was fully passed by the members of the Common Council this 19th day of July , 2015.
