

Noblesville Parks and Recreation Board Minutes October 12, 2016

MEMBERS PRESENT: Todd Thurston, Scott Noel, and Ann Minnich

OTHERS PRESENT: Brandon Bennett, Director; Mike Hoffmeister, Assist. Director; Sherry Faust, Board Secretary; Nichole Haberlin, Recreation Director; Wil Hampton, Common Council representative.

CALL TO ORDER: President Thurston called the meeting to order at 7:00pm.

APPROVAL OF AGENDA: President Thurston asked if there were any additions or deletions to the agenda. President Thurston asked for the approval of the Agenda. Mr. Noel moved to approve the Agenda as presented and Ms. Minnich seconded this motion. No further discussion was held and the motion passed unanimously.

APPROVAL OF MINUTES of September 7, 2016 Board Meetings. President Thurston said the September 7, 2016 minutes were distributed to the Board. Are there any corrections? If there are no corrections, may I have a motion to approve? Mr. Rogers moved to approve the minutes for the September 7, 2016 Board meeting and Ms. Minnich seconded this motion. No further discussion was held and the motion passed.

FINANCIAL:

1. **Approval of Claims for** October 11 and October 25, 2016. Ms. Minnich moved to approve the claims as presented totaling \$37,304.32. Mr. Noel seconded this motion and the motion passed unanimously.

2. Transfers and Appropriations: None

Mr. Bennet said all of the series are fine at this time, but he said some lines might need adjustments later, but he would be in contract with the Controller's Office to see if he should do transfers.

REPORTS

Recreation Report

Ms. Nichole Haberlin said the recreation programs are slowly increasing again, not where they once were, but on the upswing. She then reviewed her report that was in the packet with the Board. (Staff Report Attached)

• Director of Golf Report

Mr. Hoffmeister distributed Mr. Deakyne's report to the Board. He reported that 2016 September was very good. At Fox Prairie, the Board will see \$74,987 which is down from last year, but last year in the fall was awesome. 2016 is the second highest September since 2008. Forest Park was \$27,913 and again down from 2015, but up in revenue from 2012 and 2014. Overall it was a pretty good month with decent weather. Mr. Deakyne requested Mr. Hoffmeister report on merchandise; total sales is in the neighborhood of \$70,000.00, which is around \$20,000 higher than the shop was last year with the contractor. Obviously, the risk the Board took in supporting this venture is paying off. Mr. Hoffmeister said that Mr. Deakyne is going through some crediting on some of the vendor accounts where the golf division will have a credit available to use with some of the vendors. Footgolf is currently at \$5,334 to date, which is around \$2,700 behind last year. Mr. Hoffmeister said they have noticed that some golf courses are closing their footgolf courses, but Mr. Deakyne thinks we should just hang on for now and revaluate later. Golf for October has started out well.

• Assistant Director Report

Mr. Hoffmeister reported that the Bowl-a-Thon is February 18th from 1pm-5pm. He is working on pulling together three teams; Park Board, Park, and Golf teams. He also reported that work has been done on a video series for Federal Hill Commons which is being posted on FaceBook, as well as putting together a

2017 calendar. He also reported that there was a wash out at Logan Field and the Park maintenance spent two days to secure it and to help make repairs. Park events are complete for the year, except for the Community Halloween event on October 28th.

OLD BUSINESS

1. Federal Hill Commons Update

Mr. Bennett said he hopes when the members of the Board drive by Federal Hill Commons they can see the progress. It is within about 4 weeks to being 99% complete. (Staff Report Attached)

NEW BUSINESS

1. Board to consider lease termination with Boys and Girls Club for Conner Courts

Mr. Bennett explained this termination of the Board's license agreement with the Boys and Girls Club for the operation of Conner Court because of the Boys and Girls Club construction project which will being in the spring. He said the department would be removing the goals and lights from the area and that a press release will be put out to let the community know. (Staff Report Attached)

President Thurston asked for a motion to approve the lease termination. Mr. Noel moved to approve the lease termination with the Boys and Girls Club for Conner Courts as presented and Ms. Minnich seconded this motion. No further discussion was held and the motion passed unanimously.

Mr. Bennett talked to the Board about his and some of his staff's trip to the National Conference in St. Louis. He said it was a very informative conference.

With no other business to discuss, Mr. Scott Noel made a motion to adjourn and Ms. Ann Minnich seconded this motion. President Thurston adjourned the meeting at 7:40 PM.

Park Terms and Definitions:

Summary:

Work continues at Federal Hill with an anticipated completion date of Mid November. Trees are being installed across the site and topsoil is being placed as well. The main lawn has been seeded and is showing great growth of grass. Also, they continue to pour concrete on the site. The anticipation is that the playground will be installed the last week of October and the asphalt will be laid during the same time frame. The closing on the bank building is anticipated to be Friday, October 14th. We will have an Audio Visual training at the end of the month as well. Progress is on-going and this project if coming around very well.

Background:

Federal Hill Commons is the park the city determined met the best use for a 6.4 acre tract of land between 32 and Logan Street and Nixon and St. Rd. 19. The land, mostly floodplain, has been home to Dave Mason Car Repair and open space. The City will also acquire the existing Ameriana Bank in 2016 as a part of this project. Through the vision of the city as well as several focus groups, the program has been determined to include an amphitheater, event space, restrooms and storage, a farmer's market plaza, interactive water feature, shelters, trails, playground, and parking. It will also eventually be connected by a pedestrian bridge across the river from the Hamilton County Judicial Center. The project is slated to begin construction in summer and have the initial phase open 2016.

Park Terms and Definitions:

Summary:

The Boys and Girls Club of Noblesville intends to build their new facility that Conner Courts are currently located on. The courts will need to be demolished in order to accommodate the new building. Based on the License agreement, the club has given us notice of their intention to build in the spring of 2017. In order to remove the goals and the lights, we will need to get in completed in the next few weeks based on weather. It is yet undetermined if we will be able to reuse anything from he site elsewhere. We intend on removing the backboards in the next week and determine the fate of the goals from there as we have to dig to see how they are installed and if they can be moved or just have to be trashed. Upon termination of this agreement, the property will revert back to the Boys and Girls Club for them to operate and enforce how they deem fit as they are the owner.

Background:

This is a long standing lease we have had in a joint partnership with the Noblesville Schools for twenty years. The courts have been highly utilized in the warm months. The time for the courts to be removed has come based on the License agreement with the Boys and Girls Club. It has been a great asset for the community for the past 20 years.
