

Noblesville Parks and Recreation Board Minutes June 7, 2017

MEMBERS PRESENT: Todd Thurston, Carl Johnson and Anne Minnich.

CALL TO ORDER: Meeting was called to order by Park Board member, Todd Thurston at 6pm.

Mr. Thurston said in the absence of both the President and Vice-President, someone from the Park Board needs to move to elect a Chairman Pro-Tem for this meeting. Ms. Minnich moved to elect Todd Thurston to preside over this session of the Park Board meeting and Mr. Johnson seconded this motion. No further discussion was held and the motion passed unanimously.

APPROVAL OF AGENDA: Chairman Pro Tem Todd Thurston asked if there were any additions or deletions to the agenda. Chairman Pro Tem Todd Thurston asked for the approval of the Agenda as presented. Ms. Minnich moved to approve the Agenda as presented and Mr. Johnson seconded this motion. No further discussion was held and the motion passed unanimously.

APPROVAL OF MINUTES of May 3, 2017 Board Meetings. Chairman Pro Tem Todd Thurston asked for the approval of the May 3, 2017 minutes. Ms. Minnich moved to approve the minutes for the May 3, 2017 Board meeting as presented and Mr. Johnson seconded this motion. No further discussion was held and the motion passed unanimously.

REPORTS

Recreation Report

Ms. Haberlin asked that the Board please correct their report to read May instead of April as shown in the Park Board packet. She reported that they had 114 participants this month with 24 classes offered which is a decrease from last month, but it is also normal for May. She also said that the numbers for revenue at the Ivy Tech Annex is pretty much what it will be for the end of this fiscal period with them. Ms. Haberlin said the Board, later in the meeting, will be considering the new lease with them. (Staff Report Attached)

Director of Golf Report

Mr. Hoffmeister distributed Mr. Gary Deakyne's report to the Board. Mr. Hoffmeister reported that the overall revenue for May 2017 at the Forest Park Course was \$20,556.46, a difference of a negative of \$7,907.86 with the first nine out of the ten days were rain. The overall revenue for May 2017 at Fox Prairie was \$61,943.76 a difference of a negative of \$4,881.07 from 2016. Mr. Hoffmeister said overall

not a bad May and the rains did not help. Mr. Deakyne wanted Mr. Hoffmeister to pass on that things were going well and that they had a lot of new groups that are coming out to play on weekday mornings along with the seniors. Also, the outing season is around the corner. Mr. Hoffmeister said two tournaments were also canceled because of the rain.

Assistant Director Report

Mr. Hoffmeister reported that the first month of events for 2017 brought about 11,000 people to the Parks and Noblesville City which is fantastic. The Mac n Cheese event went well and have not received the revenue, but should be about \$2,000.00. Mr. Hoffmeister then directed the Board's attention to the upcoming events at the bottom of the agenda. He also reported that The Green Room is booked for every weekend in June, since they turned it into a rental facility and the majority of July has also been booked. The last thing Mr. Hoffmeister wanted to report on was Southside Park. It has taken a month to do construction but will be completely done by the Board meeting in July.

OLD BUSINESS

1. Finch Creek Park update

Mr. Hoffmeister said there was not real updates. The bids were open and awarded to Crider & Crider a couple of weeks ago for the earthwork. The Park staff had a brainstorm session with Context for ideas with the new park design.

NEW BUSINESS

1. Board to consider annual lease with Ivy Tech Community College

Mr. Hoffmeister said he was going to let Ms. Haberlin review this lease since she is the Recreation Director in charge of the Ivy Tech Annex. Mr. Haberlin said this was almost identical to the one the Board had with them this past year. (Staff Report Attached)

Chairman Pro Tem Todd Thurston asked for a motion. Mr. Johnson moved to approve the Sublease Between The Noblesville Parks & Recreation Department and Ivy Tech and Ms. Minnich seconded this motion. No further discussion was held and the motion passed unanimously.

With no other business to discuss, Mr. Carl Johnson made a motion to adjourn and Ms. Ann Minnich seconded this motion. Chairman Pro Tem Todd Thurston adjourned the meeting at 6:35 PM.

NOBLESVILLE PARKS AND RECREATION REPORT MAY 2017

<u>Enrollment:</u> As of April 23th we had 114 participants in our programs this month with 24 classes offered. 14 classes ran. This is a decrease in participation from last month of 133 participants (normal for the month of May), and a decrease of 82 participants from May, 2016. Salsa for Salsa was moved from May 5th to May 12th due to rain but estimated 1000-1200 participation for our first event at Federal Hill Commons. Grand Opening moved from April 29th to May 13th due to weather we have estimated about 3500 participants. Total participants 4,814.

Park Terms and Definitions:

Summary:

Please find attached the 2017-18 annual leave with Ivy Tech Community College. This lease has been in place for two years now which allows the Noblesville Parks & Recreation Department to lease space from Ivy Tech Community College for recreation programming and rentals. This lease is reviewed and renewed annually. There are no major changes in this lease but only to clear up some language regarding the auditorium and who actually controls the booking and scheduling of it. This has officially been turned over to the Parks Department.

Background:

The City of Noblesville Parks & Recreation Department has been leasing space from Ivy Tech Community College since summer 2015. Spaces include the community gym, a wellness room, classroom space, locker rooms and most recently the auditorium. The relationship between Ivy Tech Community College and Noblesville Parks & Recreation was and still is a unique and innovative to share space and because of it, has won awards within the state of Indiana.
