ORDINANCE NO. 30-07-14

AN ORDINANCE OF THE CITY OF NOBLESVILLE, INDIANA
PROVIDING FOR REDISTRICTING IN COMPLIANCE
WITH INDIANA CODE 36-4-6-3

WHEREAS, on the 26th day of November, 2013, the Noblesville Common Council passed Ordinance No. 44-11-13, which changed the City from a third class city to a second class city as authorized by Indiana Code 36-4-1-1; and,

WHEREAS, the change from a third class city to a second class city is to be effective on January 1, 2016; and,

WHEREAS, on January 1, 2016, the elected Common Council of the City of Noblesville will increase from seven (7) members to nine (9) members, with six (6) members to be elected from districts, and three (3) members to be elected at large; and,

WHEREAS, Indiana Code 36-4-6-3 requires the legislative body of the City of Noblesville to adopt an ordinance to divide the City, as a second class city, into six (6) legislative districts which are composed of contiguous territory, are reasonably compact, do not cross precinct boundary lines subject to certain exceptions, and contain as nearly as is possible, equal populations.

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Noblesville as follows:

SECTION 1, COUNCIL DISTRICT. The City of Noblesville is hereby divided into six (6) Council Districts conforming to the requirements of Indiana Code 36-4-6-3 as follows:

The Districts shall consist of the following precincts:

(a) Council District 1: Precincts 27, 17, 24, 15, 18, 23 and 14, as defined by the Precinct maps and boundaries located in the Office of the Clerk of Hamilton County.

(b) Council District 2: Precincts 33, 36, 31, 11, 30 and 34 as defined by the Precinct maps and boundaries located in the Office of the Clerk of Hamilton County.

(c) Council District 3: Precincts 29, 16, 13, 5, 7 and 22 as defined by the Precinct maps and boundaries located in the Office of the Clerk of Hamilton County.

(d) Council District 4: Precincts 9, 20, 28, 37, 12 and 10 as defined by the Precinct maps and boundaries located in the Office of the Clerk of Hamilton County.

(e) Council District 5: Precincts 6, 8, 26, 21, 38, 39, and Delaware 2, as defined by the Precinct maps and boundaries located in the Office of the Clerk of Hamilton County.

(f) Council District 6: Precincts 32, Wayne 5, Wayne 4, Wayne 3, Wayne 6 (NV) and Fall Creek 13, as defined by the Precinct maps and boundaries located in the Office of the Clerk of Hamilton County.

SECTION 2. REPEALER AND EFFECTIVE DATE. Any ordinance or any parts thereof in conflict herewith are hereby repealed. This Ordinance shall be effective upon passage and the Clerk-Treasurer shall provide a copy of this Ordinance to the Clerk of Hamilton County to make the changes to the City's Council districts for the 2015 primary election.
