

ORDINANCE NO. 39-09-19

AN ORDINANCE TO AMEND NOBLESVILLE PARKING ORDINANCES

WHEREAS, the City of Noblesville Common Council now desires to amend Sections 72.17, 72.90, 72.93, 72.94 and Schedules V, VII and VII of Chapter 78, respectively, of the Noblesville City Code.

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Noblesville, Indiana, as follows:

1. Section 70.50 of the Noblesville City Code is hereby amended and restated as follows (additions in underline, deletions in ~~strikethrough~~):

For purposes of Title VII of the Noblesville City Code, a person who violates the traffic code shall be the driver of the vehicle, if the driver can be identified by law enforcement at the time of the infraction. If the driver of the vehicle cannot be identified at the time of the infraction, the owner(s) of the vehicle shall be liable for any violation.

(A) Whenever a person is charged with a violation of this traffic code, he shall be given notice of such charge by an appropriate notice served personally or placed in or upon a vehicle stopped or parked in violation of any provision hereof.

(B) If, in the opinion of the Police Chief or his officers or other duly constituted officer, any person charged with violating this traffic code is about to leave the jurisdiction, such officer may institute action forthwith before a court of law, Magistrate or Judge for the collection of such fine and penalty.

2. Section 70.99(B) of the Noblesville City Code is hereby amended and restated as follows (additions in underline, deletions in ~~strikethrough~~):

§ 70.99 PENALTY.

(B) Each violator of any other provision of this traffic code shall pay a fine and penalty to the City, not to exceed \$300 for each such violation. Violators who do not wish to pay a fine or penalty must file an appeal within fifteen (15) days of the date of the issuance of notice of the violation. The appeal shall be docketed in the Noblesville City Court and made subject to the costs imposed for Class A infractions in addition to the fee imposed by the City Court. All unpaid violations may be docketed in the Noblesville City Court and made subject to the costs imposed for Class A infractions in addition to the fine imposed by the City Court.

3. Section 72.17 is added to the Noblesville City Code and shall read as follows:

§ 72.17 PARKING IN CITY PARKING LOTS AND GARAGES.

Any and all motor vehicles utilizing a parking space in a City parking lot or parking garage shall utilize such space by "head-in" parking only, which is where the vehicle is parked with the front of the motor vehicle is closest to any parking wheel stop, if any, and facing away from the

parking lot traffic lane. Parking by backing into parking spaces, or any other form of parking other than "head-in" is prohibited.

It is unlawful and an infraction for any person to do any act forbidden or fail to perform any act required in this traffic code, unless provided otherwise under Indiana law.

4. Section 72.90 of the Noblesville City Code is amended to read in its entirety as follows:

§ 72.90. PARKING RATES AND FEES.

Fees for annual parking permits and meters shall be as follows:

- (A) Three hundred dollars (\$300) per year, or \$25 per month, for the following parking lots identified on the "Downtown Parking Map" (Exhibit 1 to Chapter 78, attached to and made a part of this traffic code): Red Lot, Future Parking (to be the Levinson), and the Orange Lot.
- (B) Two hundred fifty dollars (\$250) per year for the following parking lots identified on the "Downtown Parking Map" (Exhibit 1 to Chapter 78, attached to and made a part of this traffic code): City Hall East Lot and designated spaces on Clinton Street.
- (C) One hundred fifty dollars (\$150) per year for the following parking lot identified on the "Downtown Parking Map" (Exhibit 1 to Chapter 78, attached to and made a part of this traffic code): the Purple Lot.
- (D) Twenty-five cents (\$0.25) per hour for all metered parking. Surcharges for payment by credit card will apply as posted or stated during the payment process.

5. Section 72.93 of the Noblesville City Code shall be amended to read in its entirety as follows:

§ 72.93. PARKING LOTS AND GARAGES.

The parking lots and garages available for public parking are identified in the map labeled "Downtown Parking Map" (Exhibit 1 to Chapter 78, attached to and made a part of this traffic code). Enforcement at parking lots and garages shall be from 8 a.m. to 5 p.m.

6. Section 72.94 of the Noblesville City Code shall be amended to read in its entirety as follows:

§ 72.94. REMOVED

7. Schedule V of Chapter 78 of the Noblesville City Code is hereby amended and restated as follows (additions in underline, deletions in ~~striketrough~~):

8. Schedule VII of Chapter 78 of the Noblesville City Code is hereby amended and restated as follows (additions in underline, deletions in ~~strike through~~):

SCHEDULE VII. PARKING TIME LIMITED

The City establishes Downtown Square Parking as follows:

<u>8th St.</u>	<u>Clinton St. to Maple Ave.</u>
<u>9th St.</u>	<u>Clinton St. to Maple Ave.</u>
<u>Logan St.</u>	<u>White River to 10th St.</u>
<u>Conner St.</u>	<u>6th St. to 10th St.</u>

Parking spaces in the Downtown Square Parking shall be free for motor vehicles up to two consecutive hours each calendar day (excluding Saturdays, Sundays and City holidays) during the hours of 9 a.m. until 5 p.m. The two consecutive hour period for each calendar day (excluding Saturdays, Sundays and City holidays) shall begin at 9 a.m. or immediately upon parking, whichever is later, and end two hours later. Furthermore, the two consecutive hour period shall be limited where signage indicates that special parking duration limitations apply. Parking is otherwise unlimited in these areas.

Parking is further restricted in the same manner in the City outside the Downtown Square Parking as identified below:
